### 5. How we use Personal Information

## Privacy Notice

Personal information means any information about a person from which that individual can be identified. Bortstein Legal Group processes personal information in a number of different situations, set out in the sections below.

If you provide information to us about any person other than yourself, your employees, counterparties, your advisers or your suppliers, you must ensure that they understand how their information will be used, and that they have given their permission for you to disclose it to us and for you to allow us, and our outsourced service providers, to use it.

- a) If you are a client, or an officer, employee, or contractor of a client of Bortstein Legal Group, see below for further details.

### *Categories of personal information we collect:*

To act for your organization and/or advise you as a client, we will need to collect personal information about you, including your name, role at work, work address, work contact details and business details. We will, from time to time, also collect data on your areas of expertise and experience and your business interests.

Where we are required by law, we will collect certain identifying information about you to comply with our professional conduct obligations, including your name, address or regulatory status or identity documents.

In the course of any particular matter that we are working on for you, we will from time to time collect other personal information about you that is relevant to the matter. Usually, we obtain this personal information directly from you or from your colleagues but may also from time to time obtain personal information about you from third parties or public sources (for example, we may obtain data about your directorships from a company search or from your other advisors).

To act for clients, Bortstein Legal Group will process the personal information of individuals who are involved in or connected to client matters, e.g., representatives of organizations that clients are contracting with and their legal advisors and consultants. It may include both individuals who are connected with our client, and individuals who are connected with other parties involved in the transaction.

### *Categories of personal information we collect:*

In the course of any matter, we will collect personal information about individuals who are involved in or connected with the matter and the types of personal information we collect will depend on what is necessary for and relevant to the matter. The data we usually collect for a matter includes your name, role, address, contact details and business details.

In the course of any particular matter that we are working on, we will, from time to time, collect other personal information about you that is relevant to the matter. Usually, we obtain this personal information directly from you or from your colleagues but may also from time to time obtain personal information about you from third parties or public sources.

Bortstein Legal Group may process certain personal information about individuals with whom it would like to develop a business relationship or whom it targets for business development and marketing activities and communications.

*Types of personal information we collect:*

We will collect personal information about you, including your name, job title, position, address, contact details and business details, as well, from time to time, your areas of expertise and experience and your business interests. If we invite you to an event, we will occasionally ask for additional personal information about your dietary or accessibility requirements. This would include sensitive personal information (known as special categories of personal data under some data protection laws), such as inferred information about your religion or health status.

Usually, we will obtain this personal information directly from you, such as via an email signature or business card but may also obtain information about you from a third party, such as a colleague or a public source, for example a LinkedIn profile.

To engage your organization as a supplier, we will need to collect personal information about you, including your name, role, work address, work contact details and business details.

e) If you are a candidate applying for a role at Bortstein Legal Group, see below for further details.

We will process personal information about individuals who have applied for a role at Bortstein Legal Group for recruitment purposes.

*Types of personal information we collect:*

The personal information we collect in order to progress your application as a candidate will include personal contact details such as name, title, addresses, telephone numbers, personal email addresses, date of birth, gender, current salary, compensation history, annual leave entitlement, pension and benefits information, current notice period and other employment records from previous roles, start date and location of employment; recruitment information (including copies of right to work documentation, references and other information included in a CV, cover letter or as part of the application process) and visual images and any photographs provided for business purposes. We will collect such personal information directly from you, or indirectly from recruitment agents or public sources, such as LinkedIn. If you are successful in your application, to the extent relevant, we will transfer this personal information to your employment record.

We will process personal information about individuals who visit our website. This information is collected automatically, subject to our Cookie Notice and your choices in our cookie banner.

The personal information we collect when you access our website may include your IP address, city, browser minor version, browser user-agent string, device brand, device model, device name, operating system minor version, platform minor version, screen resolution.

## 6. Sharing Personal Information

We disclose your personal information to third-party service providers who provide administrative or professional assistance, storage, security, telecommunications, and other services to us in support of our business, including secure remote working environments and office cloud software.

We ensure that all such suppliers are subject to contractual obligations to protect personal information appropriately, in accordance with data protection law.

### 7. International Transfers of Personal Information

In order to provide our services, from time to time, we transfer your data (i) outside of the United Kingdom or European Economic Area, such as to our offices in North America or to a service provider with servers outside those countries; and (ii) outside of Canada, such as to our offices in the United States, the United Kingdom, European Economic Area or to a service provider with servers outside those countries or areas. When this happens, we will ensure that the information is protected as described in this Privacy Notice. Please see below for further information about the appropriate safeguards that we implement.

Bortstein Legal Group ensures that an equivalent degree of protection is implemented by only transferring personal information to countries with adequate data protection regimes or using appropriate safeguards, such as specific contracts approved by the European Commission or UK government (as applicable) which give personal information the same protection it has in the UK or EU (e.g. [European Commission: Standard contractual clauses for international transfers](#) and the [UK International Data Transfer Agreement or Addendum](#)) or any data transfer mechanism approved by the European Commission or the UK authorities as appropriate, such as the [EU-US Data Privacy Framework](#) and the [UK Data Bridge](#).

### 8. Security of Personal Information

We have put in place and maintain appropriate security measures to prevent your personal information from being accidentally lost, used, or accessed in an unauthorized way, altered or disclosed.

Noted below is further information about the security measures we implement.

Third parties will only process your personal information where they have agreed to treat the personal information confidentially and to apply appropriate security measures.

All Bortstein Legal Group staff work exclusively in a secure virtual environment with multi-factor authentication, except when they work on client systems at a client's request. The firm uses a real-time active threat detection tool as part of our internal vulnerability management process which monitors Bortstein Legal Group's infrastructure 24/7 and blocks access (in or out) to any internet activity or email it sees as a threat and provides reporting whenever it identifies any potential issues.

The data stored with Bortstein Legal Group is encrypted in transit and at rest, including mobile devices which are encrypted using an accepted Mobile Device Management (MDM) solution.

Bortstein Legal Group has procedures in place to deal with any suspected personal information breach and will notify you and any applicable regulator of a breach where appropriate and required under applicable law.

### 9. Retention of Personal Information

Bortstein Legal Group will only retain personal information for as long as it has a legitimate basis for doing so, including for the purposes of satisfying any legal, regulatory, commercial, accounting, or reporting requirements.

To decide on the appropriate retention period for personal information, we consider the amount, nature, and sensitivity of the personal information, the potential risk of harm from unauthorized use or disclosure of your personal information, the purposes for which we process your personal information and whether we can achieve those purposes through other means, and the applicable legal requirements.

Bortstein Legal Group generally retains client documentation and matter files for as long as there is an ongoing client relationship and an appropriate period thereafter, and once Bortstein Legal Group has no legal or commercial reasons to retain personal information, it will be securely deleted or destroyed.

### 10. Consent under Canadian Privacy Laws

If you are in Canada, we will not collect, use, or disclose your personal information without your prior consent. Your consent may be expressed or implied. You may expressly give your consent in writing, verbally or through any electronic means. In certain circumstances, your consent may be implied by your actions. For example, providing Bortstein Legal Group personal information to apply for a job or to use Bortstein Legal Group's services is implied consent to use such information. Bortstein Legal Group assumes that you have consented to its reasonable collection and use of personal information consistent with the purposes for which the information was given.

We do not collect, use, or disclose personal information without consent unless authorized or required by law to do so.

You may withdraw consent at any time, subject to legal or contractual restrictions and reasonable notice. In order to withdraw consent, you must provide notice to Bortstein Legal Group in writing.

### 11. Your Rights

Individuals located in the **United Kingdom, European Economic Area and Equivalent Data Protection Regimes:**

## Privacy Notice

If you are located in the United Kingdom or the European Economic Area or other locations with equivalent data protection regimes, you may have certain rights under applicable data protection laws in relation to your personal information. Please see below for further details.

*a. Request access to your personal information*

This right is commonly known as a “data subject access request” and enables you to receive a copy of the personal information we hold on you and to check that we are lawfully processing it.

*b. Request correction of the personal information that we hold about you*

This right enables you to have any incomplete or inaccurate information we hold about you corrected. Please keep us informed if your personal information changes during your relationship with us.

*c. Request erasure of your personal information*

This right enables you to ask us to delete or remove personal information where there is no good reason for us continuing to process such personal information. You also have the right to ask us to delete or remove your personal information where you have exercised your right to object to processing (see below).

*d. Object to processing of your personal information*

Where we are relying on a legitimate interest (or those of a third party) and there is something about your particular situation which makes you want to object to processing on this ground, you may exercise this right. You may also object if we ever process your personal information for direct marketing purposes.

*e. Request the restriction of processing of your personal information.*

This right enables you to ask us to suspend the processing of personal information about you, for example, if you want us to establish its accuracy or the reason for processing such personal information.

*f. Request the transfer of your personal information to another party.*

This right enables you to request for your data to be transferred to another party in a portable format.

If you want to exercise any of these rights, please contact us. We may need to request specific information from you to help us confirm your identity and ensure your right to access the information (or to exercise any of your other rights). This is another appropriate security measure to ensure that personal information is not disclosed to any person who has no right to receive it.

You will not have to pay a fee to access your personal information or to exercise any of the other rights, unless the request is repetitive, clearly unfounded, or excessive, in which case we reserve the right to charge you a reasonable fee or refuse to comply with the request.

### Residents of Canada

Upon request, Bortstein Legal Group will provide you information regarding the existence, use and disclosure of your personal information and you will be given access to that information. Bortstein Legal Group will respond to an application for individual access to personal information within a reasonable time and at minimal or no cost to the individual. You may challenge the accuracy and completeness of the information and have it amended as appropriate.

NOTE: In certain circumstances, Bortstein Legal Group may not be able to provide access to all of your personal information that it holds. Exceptions may include information that is prohibitively costly to provide, information that contains references to other individuals, information that cannot be disclosed for legal, security or commercial proprietary reasons. Bortstein Legal Group will provide the reasons for denying access.
